The new proposal provides that no new social, professional, or academic organization whose constitution or policy permits discrimination because of race, creed, or color shall be admitted to the Bucknell campus, and calls for the appointment of a committee to work with present campus organizations for the elimination of discrimination at the earliest possible time.
